



Gritt's Farm Spring Professional Photography Policy Request & Agreement

Fall 2023 - Updated Seasonally

Photography Session Times:

- Photography sessions may only take place during farm business hours of operation or special event hours listed on your ticket. NO sessions are permitted before/after business hours.
- Gritt's Farm must be notified of photo session requests within 48 business hours of the desired date.
- **Submit this form by email to: events@grittsfarm.com using subject line "PHOTO SESSION REQUEST".**

Professional Photography Access:

- A Season Pass or General Admission Ticket is required to access Gritt's Fun Farm, the Pumpkin Patch, and Sunflower Fields when open. The photographer *and* client + client families (if applicable) must check-in upon arrival at the farm, prior to photo sessions.
- A Season Pass purchase includes a "Single-Day Buddy Pass" perk this year! Photographers may extend the Buddy-Pass feature to one client ONE day only throughout the season, if desired. Please note that the Buddy Pass is only valid one time, and all other clients/affiliates of the shoot must purchase a Season Pass or General Admission Ticket in order to access the farm.

Photo Credit/Social Media:

- **Gritt's Farm requests that one or more edited photos from each photography session be emailed to events@grittsfarm.com (we want to show your work!).**
- All public photos shall be identified as being photographed at Gritt's Farm. Any online photo galleries or images shall have a link to our website www.grittsfarm.com.
- If photos are posted online or on social media sites, Gritt's Farm requests attribution and that photos are tagged "@grittsfarm".

Locations:

- You may only access PUBLIC areas of the farm.
- You may NOT enter any of the areas marked "No Access", "Do Not Enter", areas with working farm equipment, construction areas, or private events.

Farm Rules

- We are a farm first! Please help us honor & respect the land & crops that we are growing.
- Please supervise all children at all times. This includes the photographer's children, if applicable.
- Ensure that plants, produce, and retail items are not tampered with.
- No flowers or produce may be picked during sessions, unless purchasing the item.
- Vehicles are NOT allowed in grassy areas, unless marked as a designated parking area.

Farm Rules

- All props must be carried to the photoshoot location. Props or equipment that cannot be carried easily should not be used. All props must be removed upon departure.
 - We require that any trash be removed from your photo site before departure.
 - Drone use is subject to approval. Email events@grittsfarm.com with an official request.
 - All photos should be family friendly in nature.
 - No public area may be blocked or made inaccessible to customers during photo shoots; the customer shopping experience may not be interrupted. Please be courteous and polite to all guests.
 - Our staff is not responsible for directing clients to your photoshoot location. Ensure clients have your contact information so that they can contact you upon arrival.
 - Gritt's Farm reserves the right to halt any photography sessions deemed to be disruptive.
 - Gritt's Farm assumes no responsibility for loss, theft, or damage to any equipment or belongings.
 - Any unauthorized portrait/commercial photography sessions may be escorted from the Farm.
